

Conference on **DATA ECONOMY LAW (DELCON 2)**

June 10, 2024 - Krems (Austria)

Following the success of our pilot event in 2023, the Center for IP, Media and Innovation Law (University for Continuing Education Krems, Austria) hosts the second **Conference on Data Economy Law (DELCON)** on **June 10, 2024** in **Krems (Austria)**. The conference is again jointly organized by an international consortium consisting of the University for Continuing Education Krems (Austria), Masaryk University (Czech Republic), Georg-August-University Goettingen (Germany) and Kazimieras Simonavicius University (Lithuania)

The modern data economy is full of new legal challenges and requires a broad-spectrum know-how and legal skills. From the use of automated systems (e.g. artificial intelligence) over big data applications to the protection of personal information – various legal issues arise in the modern data economy.

DELCON 2 focuses on these challenges and wants to provide a platform to legal researchers as well as relevant stakeholders to talk about current issues and possible solutions. The conference also accompanies the **LL.M. on Data Economy Law**. This program was jointly created by all members of the conference consortium and started in fall 2023 in Krems. Our most promising students will have the chance to present their research on their master's thesis to the audience.

For the year 2024, DELCON will be held under the following lead topic:

AI Regulation in Europe: More Rules than Innovation?

While EU takes the Lead in AI Regulation, Innovation Concerns grow

The Organizing Committee would like to invite papers on this topic. Possible subthemes include, but are not limited to:

- The AI Act and its implication to global business and law
- Challenges to IP Law and Privacy
- Risks and benefits of regulating data
- Upcoming changes in legal structures due to ongoing digitization.

For innovative papers the University for Continuing Education may grant partial scholarships for travel and accommodation. Please indicate in your submission whether you apply for a scholarship.

To submit a paper (abstract, up to 500 words) for presentation at DELCON 2, please submit your proposal to ipmi@donau-uni.ac.at by **March 31, 2024**. Abstracts will be reviewed by the project partners on a rolling basis. Decisions will be announced no later than April 10.
